- 2. To prohibit any vehicle from proceeding or remaining between the hours of 9.30 a.m. and 4.30 p.m., in the lengths of road specified in Schedule 2 to this notice, except:
 - (a) vehicles being used for fire brigade, ambulance or police purposes.
 - (b) vehicles being used for works or maintenance or repair.
 - (c) with the written permission of the police or the County Council.
- 3. To prohibit any vehicle from proceeding, between the hours of 4.30 p.m. and midnight and between midnight and 9.30 a.m., in the lengths of road specified in Schedule 2 to this notice, except: (a) vehicles being used for fire brigade, ambulance or police

a) venicies being used for nee brigade, ambulance or police purposes.

- (b) vehicles being used for works of maintenance or repair.
- (c) with the written permission of the police or the County Council.
- (d) vehicles being used for the purpose of delivering or collecting postal packets, as defined in section 87 of the Post Office Act 1953, to or from any premises situated on or adjacent to those lengths of road.
- (e) vehicles requiring access for the purpose of loading or unloading goods to or from any premises situated on or adjacent to those lengths of road.

(f) disabled persons' vehicles.

4. To prohibit the waiting of vehicles at any time in the lengths of road specified in Schedule 2 to this notice.

Exceptions will be provided in the proposed Order to permit waiting in the lengths of road specified in Schedule 2 to this notice, when access is permitted, for the purposes of loading, unloading, and works of maintenance, repair and the like.

Exceptions will also be provided in the proposed Order to allow vehicles displaying both a disabled person's badge and a disabled person's parking disc to wait in the lengths of road specified in Schedule 2 to this notice, when access is permitted, for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same day).

- 5. To prohibit any vehicle from proceeding in the lengths of road specified in Column 1 of Schedule 3 to this notice in a direction other than that specified in relation to that length of road in Column 2 of the said Schedule.
- To revoke The County Council of Clwyd (Various Roads, Holywell) (Traffic Regulation) Order 1989 with the exception of Articles 9, 10 and 11.
