

(f) To provide for traffic to proceed in that length of the link road between its junction with Northway and Northway Service Road from South to North.

(g) To provide for a Weight Restriction not exceeding 7.5 tonnes in Northway, from its junction with High Street to its junction with Northway Service Road (eastern end).

(h) To provide in High Street a bus stop area in which no vehicles, other than public service vehicles, may wait between the hours of 7 a.m. and 7 p.m.

Full details of these proposals are in the Draft Orders which together with a map showing the length of road referred to therein and a statement of the Council's reasons for proposing to make the Orders may be inspected at the Council Offices, Three Rivers House, Northway, Rickmansworth (Mondays to Fridays inclusive) during normal working hours.

##### *The Borough of Trafford (Westinghouse Road, Trafford Park) (Prohibition of Driving) Order 1992*

#### SCHEDULE 3

##### *No Waiting at Any Time*

*Third Avenue*, both sides, from its junction with the northern kerb-line of Westinghouse Road to its northern terminal point including its northern kerb-line, except for the lengths in Schedules 4 and 5.

#### SCHEDULE 4

##### *No Waiting, Monday to Saturday, 8 a.m. to 6 p.m.*

##### *Third Avenue:*

(i) West side, from a point 37 metres north of its junction with the northern kerb-line of Westinghouse Road to a point 20 metres south of its junction with the southern kerb-line of Fifth Street.

(ii) West side, from a point 43 metres north of its junction with the northern kerb-line of Fifth Street to a point 18 metres south of its junction with the southern kerb-line of Eighth Street.

(iii) East side, from a point 19 metres north of its junction with the northern kerb-line of Eighth Street to a point 43 metres south of its junction with the southern kerb-line of Eleventh Street.

(iv) Both sides from its junction with the northern kerb-line of Eleventh Street for a distance of 37 metres to a northerly direction.
