- That part of the footpath in Westminster Walk marked AB on the deposited plan be stopped-up, that is to say a distance of approximately 20 metres, a width of 3.7 metres to 2.5 metres parallel to the boundary of No. 14 Westminster Walk.
- That part of the footpath in Westminster Walk marked BC on the deposited plan be stopped-up, that is to say a distance of 23 metres, a width of 1.5 metres parallel to the boundary of No. 5 Westminster Walk.
- That part of the footpath in Westminster Walk marked BD on the deposited plan be stopped-up, that is to say a distance of 3 metres, a width of 2.5 metres at the rear boundary of No. 14 Westminster Walk.
