### EAST HAMPSHIRE DISTRICT COUNCIL

The East Hampshire District Council (Off-street Parking Places)
Order 1993

Notice is hereby given that the East Hampshire District Council propose to make an Order under section 35 of the Road Traffic Regulation Act 1984, to replace the East Hampshire District Council (Off-street Parking Places) Order 1992. The general effect of the Order will be to:

- (a) Extend the hours of charging in pay and display car parks in Petersfield and Alton from 8 a.m. to 5 p.m. to 8 a.m. to 7 p.m., except for Festival Hall car park, Petersfield, where charges will cease at 5 p.m.
- (b) Increase the excess charge from £20 to £30 (£15 if paid promptly).
- (c) Change the 4 hour tariff from 80p to £1 and the all day tariff from £2 to £2.50 in The Bank, Church Street, Lady Place, Manor House and Turk Street car parks, Alton, and Castle Yard, Central and Swan Street car parks, Petersfield.
- (d) Change the 1 hour tariff in Castle Yard, Petersfield, Turk Street and Church Street, Alton, car parks from 10p to 20p.
- (e) Discontinue the use of season tickets for Central, Castle Yard, Petersfield, and Church Street, Alton, car parks.
- (f) Change the 1 hour tariff from 10p to 20p and the all day tariff from 50p to £1 in Festival Hall, Petersfield, Mount Pleasant, Vicarage Hill and Victoria Road, Alton, car parks.
- (g) Change the charge for full season tickets from £250 to £275 (which will not be valid for the car parks mentioned in (a) above); change the tariff for short stay car park tickets from £60 to £90; introduce a season ticket at £275 for specified bays in Station Road, Liphook car park.
- Station Road, Liphook car park.

  (h) In Central Car Park, Petersfield, introduce a tariff for coaches at 10 times the standard rate, in marked bays only.
- Restrict the waiting period in the long stay parking bays, Midhurst Road, Liphook car park to 9 hours.

Full details of these proposals are contained in the draft Order which, together with the existing East Hampshire District Council (Off-street Parking Places) Order 1992, maps showing the off-street parking places and a statement of the District Council's reasons for proposing to make the Order, may be examined during normal office hours at the offices of the District Council, Penns Place, Petersfield,
