The Stopping-up of Highways (Glamorgan Street and Mason Street, Aberaman, Mid Glamorgan) Order 1992

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highways described in the Schedule to this notice to enable the development of residential properties, for which planning permission has been granted, to be carried out

Copies of the Order and relevant plan may be inspected at the offices of Cynon Valley Borough Council, Rock Grounds, High Street, Aberdare, Mid Glamorgan, from 18th November 1992.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds: (a) that it is not within the powers of the Town and Country Planning Act 1990; or

(b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act

he may within 6 weeks of 18th November 1992, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### SCHEDULE

#### (All distances are approximate)

The highways to be stopped up are at Aberaman in the County of Mid Glamorgan and comprise:

- that length of Glamorgan Street which extends from its junction with Chapel Street, for a distance of 9 metres in a general southeasterly direction;
- that length of Mason Street which extends from its junction with Cardiff Road, for a distance of 14 metres in a general southwesterly direction. (481)

#### **HIGHWAYS ACT 1980**

The M3 Motorway Widening (Junctions 3 and 4, Side Roads)
Order 199

The Secretary of State for Transport hereby gives notice that, in relation to the part of the M3 motorway between junctions 3 (Lightwater) and 4 (Camberley/Frimley) in the County of Surrey, he proposes to make, under Sections 18 and 125 of the Highways Act 1980, the above Side Roads Order. The effect of the Order will be to:

- (1) authorise him to:
  - (a) stop up highways; (b) construct new highways
- at Brackendale Road footbridge and Bagshot Heath footpath number 184; and a footpath to the rear of Verran Road.
- (2) provide for the transfer of each of the new highways to the authority specified in the Order as from the date on which he notifies that authority that the new highway is open for through traffic.
