- (c) Anyone wishing to cut down, top, lop or uproot a tree situated within the Conservation Area must give 6 weeks prior notice of the intention to the Local Planning Authority.

Designation of a new Conservation Area—Nailsworth Conservation Area Extensions

Notice is hereby given that Stroud District Council have designated three extensions to the Nailsworth Conservation Area.

Maps of the designated area have been deposited at the offices of Stroud District Council, Ebley Mill, Westward Road, Stroud and may be inspected at the said place during normal office hours.

The purpose of the designations are to preserve and enhance the character and appearance of this Area of Special Architectural or Historical Interest and to ensure that special regard is paid to the architectural and visual qualities of the designated area as a whole when proposals for development are under consideration. In accordance with sections 211 and 212 of the Town and Country Planning Act 1990, and section 74 of the Planning (Listed Buildings and Conservation Areas) Act 1990, respectively, subject to certain exceptions, to remove, up-root or destroy any tree in the designated area and consent is required for the demolition of all buildings in the designated area.

A brief summary of the designated areas are as follows:

The Brewery Lane extension lies to the South of the existing Conservation Area and incorporates the nineteenth century villas to the South of Bristol Road, the industrial area and mill pond at the end of Brewery Lane and the properties facing Barn Close at the northern most point.

The Old Market extension lies to the east of the existing conservation area and extends to incorporate the road, car parks and some shops and other properties as an area in need of enhancement.

The Park Road extension extends eastwards to incorporate the older properties aligning the north end of Park Road.
