*The Haringey (Free Parking Places) (Disabled Persons) (No. 10) Traffic Orders 1992*

Notice is hereby given, that the Council of the Borough of Haringey, on 19th November 1992, made the Haringey (Free Parking Places) (Disabled Persons) (No. 10) Traffic Order 1992 under section 6 of the Road Traffic Regulation Act 1984.

## LONDON BOROUGH OF MERTON

*London Borough of Merton (Free Parking Places) (Disabled Persons) (No. ) Traffic Order 1992*

*Alverstone Avenue, S.W.19*

Notice is hereby given that the Council of the London Borough of Merton under the powers conferred by section 6 of the Road Traffic Regulation Act 1984 propose to make the above-mentioned Order.

The general effect of the Order will be to:

- (a) make the present advisory markings at Alverstone Avenue, S.W.19 mandatory so that vehicles authorised by the Order may be left for any period during the permitted hours without charge;
- (b) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled persons' badge (commonly referred to as "the Orange Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.

Nothing in the Order shall apply to anything done with the permission or at the direction of a police constable in uniform.

A copy of the proposed Order, of the Merton (Free Parking Places) (Disabled Persons) (No. 1) Order 1977 (and of the Orders which have amended or applied that Order) and of the Council's statement of reasons for proposing to make the Order and a map which indicates each length of road to which the Order relates can be inspected during normal office hours on Mondays to Fridays inclusive until 12th December 1992 at the Main Reception, Crown House, London Road, Morden.
