The Melton Borough Council (Rutland Street, Goodriche Street and Thorpe End) (Prohibition of Waiting) Order 1992

Length of road in Melton Mowbray

Rutland Street, west side, from its junction with Thorpe End in a northerly direction for a distance of approximately 13 metres.

Rutland Street, east side, from its junction with Thorpe End in a northerly direction for a distance of approximately 11 metres.

Goodriche Street, west side, from its junction with Thorpe End in a northerly direction for a distance of approximately 8 metres.

Goodriche Street, east side, from its junction with Thorpe End in a northerly direction for a distance of approximately 10 metres.

Thorpe End, north side, from its junction with the east side of Goodriche Street in an easterly direction for a distance of approximately 8 metres.

Thorpe End, north side, from its junction with the west side of Goodriche Street in a westerly direction for a distance of approximately 8 metres.

Thorpe End, north side, from its junction with the east side of Rutland Street in an easterly direction for a distance of approximately 8 metres.
