London Borough of Merton (Off-street Park Places) (Amendment No.) Traffic Order 1992

Merton Car Parks

Notice is hereby given that the Council of the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, propose to make the above mentioned Order under section 32 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The general effects of the Order are:

- (i) To permanently include the Theatre (The Broadway/Palmerston Road), Centre Court and Queen's Road Car Parks in Wimbledon, and Sibthorpe Road Car Park in Mitcham on the Merton (Off-street Parking Places) Order 1979. The Car Parks shall be subject to the Schedule of this notice.
- (ii) That the Hartfield Road Car Park be subject to an altered charge, as described in the Schedule to this notice.

Nothing in the Order will apply to anything done with the permission or at the direction of a police constable in uniform.

A copy of the proposed Order, a plan identifying the area affected by the proposed Order and the council's statement of reasons for making the Order can be inspected during the council's normal office hours on Mondays to Fridays, until 4th December 1992 at the Main Reception, Merton Civic Centre, London Road, Morden, Surrey SM4 5DX.
