The Borough of Warrington (Various Streets) (Prohibition and Restriction of Waiting) (Amendment No. 32) Order 1992

Notice is hereby given that the Warrington Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972 with Cheshire County Council in exercise of the powers of the said County Council under sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, proposes to make the above Order the effect of which is to introduce the following traffic regulation:

No Waiting at Any Time

1. *Longshaw Street*, from 13.72 metres to 30 metres north of Folly Lane.
2. *Wilson Street*, from 6.10 metres to 18 metres south-east of Folly Lane.
3. *Green Lane*, Poulton with Fearnhead:
 - (a) North side from 118 metres east of Lambs Lane to 25 metres north-west of Willow Crescent;
 - (b) South side from 118 metres east of Lambs Lane to Willow Crescent.
4. *Padgate Lane*, Poulton with Fearnhead:
 - (a) North-west side from 55 metres north-east of Delery Drive to 15 metres south-west of Bruche Drive;
 - (b) Both sides from 70 metres to 170 metres north-east of Tidal Lane.
5. *Station Road*, Poulton with Fearnhead: east side from 100 metres to 104 metres south of Fearnhead Lane.
6. *Orford Avenue*:
 - (a) West side from Roome Street to 45 metres north of Synge Street;
 - (b) West side from 19.6 metres to 45 metres south of Fitzherbert Street;
 - (c) East side from Roome Street to 20 metres north thereof;

12. *Lord Street*, east side from New Road to 15 metres south thereof.

 - (a) North side from 75 metres to 175 metres east of Wilderspool Causeway;

- (a) North side from York Street to 5 metres west thereof;
- (b) South side from York Street to Lord Street.

15. *York Street*:

- (a) East side from 10 metres north to 10 metres south of New Road;
- (b) West side from Knotsford Road to 10 metres south of New Road.

16. Passage off Lord Street: from Lord Street to 5 metres south-east thereof.

17. *Hood Lane*, Great Sankey: east side from 20.8 metres north of Liverpool Road to 5 metres north of Huntley Street.

18. *Clifford Road*, Penketh:

- (a) West side from A562 Warrington Road to Lyons Road;
- (b) East side from A562 Warrington Road to 40 metres north of Lyons Road.

19. *Walton Lea Road*, from Houghs Lane to a point 177 metres west thereof.

No Waiting 9 a.m. to 6 p.m.

1. *Warrington Road*, cul de sac, Penketh: from Clifford Road to the western end of the cul de sac.

No Waiting Mondays to Saturdays 8 a.m. to 6.30 p.m.

1. *Carlisle Street*, Stockton Heath: north side from Chapel Lane to the passage at the rear of house number 11 Chapel Lane.

Waiting Limited to 20 minutes in any hour Mondays to Saturdays 8 a.m. to 6.30 p.m.

1. *Eagle Brow*, Lymm: north side from 8 metres to 13 metres west of Bridgewater Street.

2. *The Cross*, Lymm:

- (a) East side from 9 metres to 14 metres north of Pepper Street;
- (b) East side from 3 metres to 12 metres north of The Grove.

3. *Whitbarrow Road*, Lymm: north-east side from 12 metres to 32 metres south-east of Dane Bank Road.

The following existing restrictions are to be revoked:

No Waiting At All Times

1. *Eagle Brow*, Lymm: north side from 8 metres to 13 metres west of Bridgewater Street.

2. *The Cross*, Lymm:

WARWICKSHIRE COUNTY COUNCIL

The Warwickshire County Council (Various Streets, Coleshill) (Prohibition and Restriction of Waiting) (Variation No. 2) Order 19

Notice is hereby given that Warwickshire County Council proposes to make the above Order under the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the waiting of vehicles in lengths of road in Coleshill as mentioned in the Schedule below.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.
