INSURANCE COMPANIES ACT 1982

Notice of direction under section 11

Notice is hereby given under section 12(8) of the Insurance Companies Act 1982, and that on 16th November 1992 the Secretary of State gave a direction under section 11 of the Act to Europa Insurance Company Limited. The direction provided that the Company shall cease to be authorised to effect contracts of insurance in the United Kingdom in the following General Business classes (1, 2, 3, 7, 8, 9, 10 and 13) and was given at the request of the Company. Notice of direction under section 11

Notice is hereby given, pursuant to section 12(8) of the Insurance Companies Act 1982 ("the Act") that on 4th November 1992 the Secretary of State for Trade and Industry gave a direction under section 11 of the Act to Allianz Cornhill International Insurance plc. The direction provided that the Company shall cease to be authorised to effect contracts of insurance in general business classes 3 and 10 in the United Kingdom and was given at the request of the Company. TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (Birmingham City Council) (No. 9) Order 1992" authorising the stopping-up of a length of Ada Road, Bordesley, Birmingham to enable development consisting of an extension to form a new nursery, one additional classroom and extension to the playground of St. Andrew's school.

SCHEDULE

Description of highway to be stopped-up (The distance is approximate)

The highway to be stopped-up is in the district of Bordesley in the city of Birmingham.

It is shown zebra hatched on the deposited plan and is a length of Ada Road commencing at a point 10 metres from its junction with St. Andrew's Street and extending in a south-westerly direction for a distance of 50 metres. (793)

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping Up of Highways (City of Birmingham) (No. 7) Order 1992" authorising the stopping up of a length of highway and lengths of the footway of Fenton Road, lengths of the highway verge and part widths of the footway of Denham Road and lengths of the highway of Bramley Road, all at Acocks Green, Birmingham to enable the re-development of Phase II of the Stockfield Housing Estate involving the erection of 116 houses and requiring the provision of new highways maintainable at the public expense, for which the highway authority is to be Birmingham City Council and also the improvement of existing highways.
