

POWYS COUNTY COUNCIL

The County of Powys (Church Street, Presteigne) (Prohibition of Waiting) Order 1992

Notice is hereby given that, on 26th November 1992, the County Council of Powys made the above-named Order under sections 1(1) and (2), 2(1) and (2) and 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

This Order, which will come into operation on Monday, 30th November 1992, makes it unlawful to leave a vehicle at any time along the side of the length of road known as Church Street, Presteigne, specified in the Schedule to this notice.

Exceptions in the Order permit waiting for as long as it is reasonably necessary for the following purposes:

- (a) picking-up and setting-down passengers;
- (b) loading or unloading goods;
- (c) building and demolition operations and
- (d) carrying out essential works connected with the maintenance of the road and the provision of water, gas, electricity and telecommunications services.

The Order also contains an exception permitting disabled person's vehicles to park for periods not exceeding two hours with return within one hour prohibited.

The existing no-waiting restriction on the north side of Church Street remains unchanged and has been incorporated in the Order.

A copy of the Order, together with a map showing the length of road concerned and a statement of the Council's reasons for making the Order, may be examined during office hours at Powys County Hall, Llandrindod Wells and the Post Office, Presteigne.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 30th November 1992, apply to the High Court for this purpose.

Borough of Preston (One-way) Traffic Order 1992-93

Notice is hereby given that Preston Borough Council, as agent of the highway authority, the Lancashire County Council, in exercise of its powers under sections 1, 2, 4 and 124(1)(c) and Part III of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers, proposes to make the following Order:

1. To make the following lengths of road one way:

- (i) *Waverley Road*—between New Hall Lane and Warner Road, south to north.
- (ii) *Warner Road*—east to west.
- (iii) *Lauderdale Road*—east to west.
- (iv) *Lauderdale Crescent*—south-east to north-east.
- (v) *Grafton Road*—west to east.
- (vi) *Carroll Street*—east to west.

A copy of the proposed Order, together with plans of the roads affected and a statement of the Council's reasons for making the Order may be inspected at the Town Clerk/Chief Executive's Department during normal office hours.

*The City Council of Rochester-upon-Medway (Revocation of Waiting Prohibitions and Restrictions) (Prohibition and Restriction of Waiting and Restriction of Loading and Unloading) Amendment Order 1993.**The City Council of Rochester-upon-Medway (Various Roads) (Consolidation of On-street Parking) (Residents') Amendment Order 1993.*

Notice is hereby given that the City Council, as agents for the Kent County Council, propose to make the following Orders under sections 1, 2, 4, 32, 35, 36, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers which will:

Amend the Borough of Medway (Revocation of Waiting Prohibitions and Restrictions) (Prohibition and Restriction of Waiting and Restriction of Loading and Unloading) Order 1977, as amended, the City Council of Rochester-upon-Medway (Various Roads) (Consolidation of On-street Parking) (Residents') Order 1990, as amended, the Trunk Road (Various Roads, Gillingham and Chatham) (Prohibition of Waiting, Loading and Unloading) Order 1971, as amended, so as to:

- (i) prohibit waiting at any time in additional and/or amended lengths of Ambrose Hill, Beacon Hill, Chatham Hill, Dargets Road, Fort Pitt Street, Gorse Avenue, Hills Terrace, King George Road, Maggie Hall Road, Maidstone Road, Mount Road, Palmerston Road, Robin Hood Lane, Silver Hill, Snodhurst Avenue, Swallow Rise, Upper Luton Road and Walderslade Road, Chatham; Cecil Road, Copperfield Road, Delce Road, King Edward Road, Nags Head Lane, St. Bartholomews Terrace, St. Margaret's Street and Valley View Road, Rochester; Cliffe Road, Cuxton Road, Elaine Avenue, Goddington Road and Hilltop Road, Strood; Bush Road, Cuxton and Vicarage Road, Halling;
- (ii) prohibit waiting at any time in certain lengths of Bank Street, Chilham Close, Clarence Road, Copperfield House service road, Cressey Court, Henry Street service road, Horsted Way, Illustrious Close, Primrose Close, Shipwright's Avenue and Union Place, Chatham; Breton Road, Hawkwood Close, Miles Place and New Covenant Place, Rochester; Cecil Avenue, Farmhill Avenue and Hawthorn Road, Strood; May Street and Wood Street, Cuxton; Knights Road and Trubridge Road, Hoo St. Werburgh and Church Street and Reed Street, Cliffe;
- (iii) amend the prohibition of waiting between 8 a.m. and 6 p.m. Monday to Saturday in certain lengths of Chatham Hill and Fort Pitt Street, Chatham;
- (iv) remove the restriction for no waiting between 8 a.m. and 6 p.m. Monday to Friday from The Precinct, Rochester;
- (v) amend the prohibition of waiting for a longer period than one hour in any two hours between 8 a.m. and 6 p.m. Monday to Saturday in certain lengths of Walderslade Road, Chatham, and High Street, Rochester;
- (vi) amend or add to the areas of residents' parking in certain sections of Cressey Court, Fort Pitt Hill and Rochester Street, Chatham;
