#### **ROAD TRAFFIC REGULATION ACT 1984**

The A10 Trunk Road (West Winch and North Runcton) (40 m.p.h. Speed Limit) Order 19

## **ROAD TRAFFIC REGULATION ACT 1984**

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984. The effect of the Order, which comes into force on 1st December 1992, is to restrict the speed limit to 30 m.p.h. on the A69 Trunk Road between a point 175 metres west of its junction with the C1027 and a point 148 metres east of its junction with the C1026, a total distance of 1071 metres.
