MEDICINES ACT 1986

European Pharmacopoeia: Approved Synonyms

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65(8) of the Medicines Act 1968 that the Medicines Commission has approved as a synonym for a name in the left-hand column of the list set out below (being a name at the head of a monograph in the European Pharmacopoeia), the name or names corresponding to it in the right-hand column of that list, with or without any of the following modifications:

- a change in the order of the words in the right-hand column, with the addition of a preposition if necessary;
- the use of the syllable 'sulf' instead of 'sulph' and *vice versa*;
- the use of the syllable 'cef' instead of 'ceph' and *vice versa*;
- the use of square brackets for round brackets and *vice versa*;
- the use of diphthongs where 'ae' or 'oe' appear on combination;
- the use of the symbol '%' instead of the words 'per cent';
- the use of the abbreviation 'Inj' instead of 'Injection'.

The subject matter of the list set out below shall take effect on 1st January 1993, and is supplementary to the list of Approved Synonyms published in 1988.

Deletions from the European Pharmacopoeia

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65(7) and (8) of the Medicines Act 1968 that on and after 1st January 1993 the monographs for Corticotrophin Zinc Hydroxide Injection (No. 479: 1986), Corticotrophin for Injection (No. 480: 1986) and Oxytocin Injection (No. 519: 1986) published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia shall cease to form part of the Second Edition of the European Pharmacopoeia. Amendments and Additions to the European Pharmacopoeia

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65(7) and (8) of the Medicines Act 1968 that on and after 1st January 1993, the monographs contained in the sixteenth fascicule of the Second Edition of the European Pharmacopoeia, published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia together with the amendments and additions to the Second Edition of the European Pharmacopoeia adopted by the European Pharmacopoeia Commission on 25th June 1992, and referred to in the Schedule hereto, are to have effect for the purposes of section 65 of the said Act.

Additions

- Human Insulin.

RADIOACTIVE SUBSTANCES ACT 1960

Authorisation to dispose of radioactive waste

Notice has previously been given that the Chief Inspector of Her Majesty's Inspectorate of Pollution and the Minister of Agriculture, Fisheries and Food are proposing to issue revised certificates of Authorisation in accordance with the Radioactive Substances Act 1960 for the disposal of liquid and gaseous radioactive waste from the Nuclear Electric Plc premises at Sizewell a Nuclear Power Station, Sizewell, near Leiston, in the county of Suffolk.

The previous notice invited comments by 25th December 1992. It has been decided to extend this period to 8th January 1993.

Copies of the draft certificates of Authorisation can be inspected at the Colchester, Clacton, West Mersea, Maldon, Southminster, Burnham and Chelmsford Public Libraries in Essex and at the offices of Essex County Council and Maldon District Council during normal working hours.
