The effect of the Order as confirmed is to divert the public right of way at Knutshaw Bridge, Wigan Road, running from point A to point B shown by a bold black line on the Order plan to a line running from point A in a south-easterly direction for a distance of 58 metres and then in a south-westerly direction to point B for a distance of 30 metres shown by a dashed black line on the Order plan.
