TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-Up of Highways (Wyncliff Road, Pentwyn, Cardiff, South Glamorgan) Order 1993

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this notice to facilitate the relocation of a gatehouse, for which planning permission has been granted, to be carried out.

Copies of the Order and the relevant plan may be inspected, free of charge, during normal opening hours at Pentwyn Community Education Centre, Glyn Coed Road, Pentwyn, Cardiff (Monday to Friday 9 a.m. to 3 p.m., Saturday 10 a.m. to 12 noon) during a period of 6 weeks from 4th February 1993.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- that it is not within the powers of the Town and Country Planning Act 1990, or
- that this interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may, within 6 weeks of 4th February 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(all distances are approximate)

The highway to be stopped up is at Pentwyn, Cardiff, in the County of South Glamorgan. It is shown by zebra hatching on the deposited plan and is that length of Wyncliff Road, including the hammerhead shaped turning area which extends from a point 22 metres south-west of its junction with Pentwyn Road in a south-westerly direction for a distance of 155 metres. ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A55) (Bodelwyddan-St. Asaph, Clwyd) (Closure of Central Reservation Crossings) Order 199

Notice is hereby given that, the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to close the gaps in the central reservation of the Chester-Bangor Trunk Road (A55) (hereinafter referred to as "the trunk road") between a point 1,064 metres east of the centrepoint of the Engine Hill Interchange Overbridge to a point 2,610 metres east of the centrepoint of the said Overbridge, and to revoke the provisions of the Trunk Road (A55) (Bodelwyddan-St. Asaph, Clwyd) (Prohibition of U-Turns) Order 1986.

The Order is considered necessary in the interests of public safety as a consequence of constructing a grade separated interchange to serve the St. Asaph Business Park, which will provide alternative routes for traffic affected by the closures.

A copy of the draft Order, the Order being revoked, together with a plan and a statement of reasons for the making of the Order, may be inspected at St. Asaph Post Office, Chester Street, St. Asaph, Clwyd, from Mondays to Fridays between the hours of 9 a.m. to 1 p.m. and 2 p.m. to 5.30 p.m., and on Saturdays from 9 a.m. to 12.30 p.m. Copies of the draft Order may also be obtained, free of charge, from the address and quoting the reference below.

Objections, specifying the grounds on which they are made, and quoting reference ZC 510-2-1-57, must be sent in writing to the Welsh Office, Highways Directorate, Road Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 4th March 1993. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
