The inquiries will be held by G. E. Winch, a person appointed, on the nomination of the Lord Chancellor, by the Secretaries of State for the Environment and Transport for the purpose of the inquiries into the Durham Western By-pass Orders.

The Durham Western By-pass Orders in question are-

- 1. The A167 Trunk Road (Durham Western By-pass and Slip Roads) Order 199, which was published in draft on 11th June 1991 and 15th October 1992. This is an order under sections 10 and 41 of the Highways Act 1980 which, if made, would provide that certain roads which the Secretary of State for Transport proposes to construct along routes described in the Order shall become trunk roads from the date when the Order comes into
- The A167 Trunk Road (Sniperley Park Roundabout to Cock o' the North Roundabout) (De-trunking) Order 199, which was published in draft on 11th June 1991 and 15th October 1992. This is an Order under sections 10 and 12 of the Highways Act 1980, which, if made, would provide that a length of the A167 Trunk Road between a point 50 metres north of the centre of the Sniperley Park Roundabout and a point 25 metres south of the centre of the Cock o' the North Roundabout shall cease to be a trunk road and shall be classified as a principal road from the date on which the Secretary of State notifies the County Council of Durham that the new trunk roads referred to at 1 above are open for traffic.

3. The A167 Trunk Road (Durham Western By-pass Side Roads) Order 199, which was published in draft on 11th June 1991 and 15th October 1992. This is an Order under sections 12, 14 and 125 of the Highways Act 1980, which, if made, would:

(a) authorise the Secretary of State for Transport to improve highways, stop up highways, construct new highways, stop up private means of access to premises, and provide new means of access to premises, in the vicinity of the routes of one or more of the new trunk roads (described in 1 above) or the A167 Trunk Road, all in the County of Durham.

(b) provide for the transfer of each new highway to the County Council of Durham as highway authority; and

(c) provide that certain of the new highways shall be

classified as principal and classified roads.

4. The A167 Trunk Road (Sniperley Park) (One-way Traffic) Order 199, which was published in draft on 11th June 1991 and 15th October 1992. This is an Order under sections 1(1), 2(1) and (2) and 122A of the Road Traffic Regulation Act 1984, which if made, would prohibit any vehicle from proceeding in the length of the Trunk Road from a point 720 metres north of the centre of Sniperley Park Roundabout to its junction with

that roundabout in any direction other than southwards.

The A167 Trunk Road (Durham Western By-pass)
Compulsory Purchase Order (No. N) 199, which was published on 18th and 25th June 1991 and 5th and 12th November 1992. This is an Order under sections 239 and 240 of

the Highways Act 1980 and under section 2 of the Acquisition of Land Act 1981 which, if made, would authorise the Secretary of State for Transport to purchase compulsorily the land described in the Schedule to the Order for the purpose of:

(a) the construction of a new trunk road,

(b) the construction and improvement of other highways,

(c) the improvement of the Trunk Road,

(d) the diversion of watercourses and the execution of other works on watercourses in connection with the improvements,

(e) the provision of new means of access to premises, and
(f) use by the Secretary of State in connection with the above works.

Proceedings on the draft Orders are being taken concurrently in accordance with section 257 of, and paragraph 20 in Schedule 1 to, the Highways Act 1980.

He will also, at his discretion, hear representations from any other persons who may desire to appear and be heard.
