TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Oldford Estate, Welshpool, Powys) Order 1993

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping up of the highways described in the Schedule to this Notice to enable the development of a housing estate, for which planning permission has been granted, to be carried out.

The Order requires to provision of new roads, which will incorporate major parts of the highways to be stopped up, and which will be highways maintainable at public expense, for which Powys County Council shall be the Highway Authority.

Copies of the Order and the relevant plans may be inspected at Montgomeryshire District Council, Council Office, Severn Road, Welshpool, Powys during normal office hours during a period of 6 weeks from 20th March 1993.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may, within 6 weeks of 20th March 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### SCHEDULE

#### (All distances are approximate)

The highways to be stopped up are at the Oldford Estate, Welshpool in the County of Powys. They are shown by zebra hatching on the first deposited plan and comprise:

- 1. that length of highway known as Queen's Drive, which extends from its junction with Prince of Wales Drive in a general northeasterly direction for a distance of 124 metres to a point 52 metres west of its junction with Leighton View.
- that length of highway known as Queen's Drive which extends from a point 51 metres south-east of its junction with Oldford Rise in a south-easterly direction for a distance of 41 metres.
