Town and Country Planning Act 1990

The Stopping-up of Highways (Butcher Street, Rhosllanerchrugog, Wrexham, Clwyd) Order 1993

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this notice, to enable the development of residential properties, for which planning permission has been granted, to be carried out.

Copies of the Order may be inspected, during normal office hours at the offices of Wrexham Maelor Borough Council, Guildhall, Wrexham

If any person desires to question to validity of the Order, or of any provision contained therein on the grounds:

(a) that it is not within the powers of the Town and Country Planning Act 1990; or

(b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act

he may within 6 weeks of 12th May 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### SCHEDULE

#### (All distances are approximate)

The highway to be stopped-up is at Rhosllanerchrugog in the County of Clwyd and is that length of Butcher Street, which extends from its junction with High Street, to a point 70 metres north of its junction with Broad Street including the whole of the easterly spur.

#### **TOWN AND COUNTRY PLANNING ACT 1990**

#### **ROAD TRAFFIC REGULATION ACT 1984**

De-Restriction of Lengths of the A500 Nantwich Bypass Trunk Road at Nantwich

Notice is hereby given that the Secretary of State for Transport proposes to make an Order under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984.

The effect of the Order will be that the lengths of the A500 trunk road specified in the Schedule to this notice shall cease to be restricted to a 30 m.p.h. speed limit by virtue of its system of street lighting, and shall be subject to the national speed limit of up to

60 m.p.h. for single carriageway roads.
