Notice of application for a licence to obstruct or impede the flow of an inland water by means of impounding works and to abstract water

Notice is hereby given that an application is being made to the National Rivers Authority (Anglian Region) by E. A. Sheardown & Co. Limited, of Westfield Farm, Marston, Grantham, Lincolnshire, for a combined licence to obstruct or impede the flow of a tributary of the Sand Beck by means of an impounding dam at National Grid Reference SK89004640 in the Parish of Hougham in the District of Grantham in the County of Lincolnshire, and to abstract 29,045 cubic metres of water between December in one year and March in the next year in any year from the River Witham at or near National Grid Reference SK88304470 in the Parish of Hougham in the District of Grantham in the County of Lincolnshire. The water abstracted from the River Witham will be taken along an underground pipe system and discharged into the tributary of the Sand Beck where it will then be re-abstracted at National Grid Reference SK89004640 (the point of the impoundment dam) for transfer into an off-channel winter storage reservoir constructed between National Grid References SK88954625 and SK89014650 for re-abstractation therefrom for spray irrigation purposes during the period April to September in each year.

AVON COUNTY COUNCIL

City of Bristol—Traffic Orders Pay and Display Parking

Notice is hereby given that the County Council of Avon proposes to make the following Orders under sections 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended:

1. The County Council of Avon (Outer Zone, City of Bristol) (Controlled Parking) (Variation No. 9) Order 199 the effect of which will be to vary further the County Council of Avon (Outer Zone, City of Bristol) (Controlled Parking) Order 1985 so as:

(a) to convert the existing meter controlled designated parking places situated in Berkeley Square, Great George Street and Park Place to pay and display parking places. The charge payable at the relevant pay and display machine, will be five pence for three minutes with a maximum period of waiting of two hours between the hours of 8 a.m. and 6 p.m., on any day other than Sunday, and

(b) to correct minor anomalies in the Order as a consequence of previous variations.

2. The County Council of Avon (Inner Zone, City of Bristol) (Controlled Parking) (Variation No. 5) Order 199 the effect of which will be to vary further the County Council of Avon (Inner Zone, City of Bristol) (Controlled Parking) Order 1985 so as to convert the existing meter controlled designated parking places situated in Quakers Friars to pay and display parking places. The charge payable at the relevant pay and display machine, will be ten pence for five minutes with a maximum period of waiting of one hour between the hours of 8 a.m. and 6 p.m., on any day other than Sunday.

The excess charge payable at pay and display parking places will be £30 discounted to £20 for payment within fourteen days. The classes of vehicles which may use a pay and display parking place are passenger vehicles, car derived vans, goods vehicles, motor cycles and invalid carriages.

Full details of the proposal are contained in the draft Order, which together with a map, a statement of the Council's reasons for proposing to make the Order and a copy of the Orders to be varied, may be inspected at the undermentioned offices (callers should report to Reception and ask for the Statutory Orders section) during normal office hours.
