

The effect of the Order, which will come into operation on 31st May 1993 (as described in a Notice of Proposals previously published in *The London Gazette* dated 28th February 1992 issue No. 52848 on page 3625 ref. 545), will be to restrict vehicles, including pedal cycles, from certain areas in The High, Town Centre, Harlow, including Broadwalk, East Walk, Market Square, West Gate, Post Office Walk, Cross Street, Civic Square and The Water Gardens, but with exceptions such as for Emergency Service Vehicles, Market Traders Vehicles, Council Vehicles and Disabled Persons Vehicles.

Minor modifications to the Order have been made namely:

- (i) "Market Trader Vehicle" means "any vehicle being owned and used by a Market Trader and who is authorised by the Council to operate a market stall in the Harlow Market Square, The High and which vehicle is used for the setting-up, erection and/or dismantling of the said Market Traders Stall".
- (ii) The restriction of vehicles from the area of the said Town Centre will not apply to a "Market Traders Vehicle" on market days when being used to set-up erect and/or dismantle the Market Traders Stall in Harlow Market Square, The High and the said vehicle enters and exits the Market Square directly from East Gate only.
- (iii) An additional exemption from the said restrictions will apply to "delivery vehicles wishing to gain access to and egress from the service lifts in Cross Street, Harlow".

A copy of the modified sealed Order may be inspected during normal office hours on the Public Notice Board at the Town Hall, Harlow and at the Local Government Library (E Block) Essex County Council, County Hall, Chelmsford, photocopies of which may be obtained subject to paying the reasonable charges of the Council.

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers of the relevant enabling Act, or that a requirement of any such enabling Act, or of any relevant regulations made thereunder, have not been complied with may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.

KNOWSLEY METROPOLITAN BOROUGH COUNCIL

*The Council of the Borough of Knowsley, Cherryfield Crescent,
Kirkby (Prohibition of Driving) Order 1993*

Notice is hereby given that on 3rd June 1993, the Council of the Borough of Knowsley made an Order under section 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984.

When this Order comes into effect on 15th June 1993, no person(s) will be allowed to cause or permit any vehicle to enter or proceed along that part at Cherryfield Crescent from a point 129 metres from its south-easterly junction with Cherryfield Drive, for a length of 20 metres in a north-westerly direction as delineated on Drawing No. TES/TM/782.

Exemptions will allow any person to cause or permit any vehicle to enter or proceed in the said length of road:

- (a) where the vehicle is a vehicle of any description and is using the highway:
 - (i) for police, ambulance or fire brigade purposes;
 - (ii) on behalf of a statutory undertaker and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telegraphic line as defined in the Telecommunications Act 1984 under, in, on, over, along or across the highway or any land adjacent to the highway; and
- (b) where the vehicle is a vehicle being used by the Local Highway Authority in pursuance of their statutory powers and duties.

A copy of the Order together with a map showing the prohibition and restriction areas may be examined at the receptions of the Municipal Buildings, Kirkby and Huyton, the Council Offices, Delph Lane, Whiston and the Council Offices, High Street, Prescot, between the hours of 9 a.m. and 5 p.m., Monday to Friday.

If you wish to question the validity of the Order or of any provision contained within it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any Instrument made

under it has not been complied with in relation to the Order, you may, within 6 weeks of 3rd June 1993, apply to the High Court for this purpose.

KNOWSLEY METROPOLITAN BOROUGH COUNCIL

*Knowsley Metropolitan Borough Council (Greenes Road, Whiston)
(Prohibition of Waiting) (Revocation) Order 1993*

Notice is hereby given that on 7th June 1993, the Council of the Borough of Knowsley made an Order under section 1(1) and (3), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984.

2. When this Order comes into effect on 11th June 1993:

(a) no person(s) will be allowed to cause or permit any vehicle to wait:

(1) at any time in the following lengths of road:

(i) *Greenes Road*, both sides, from its junction with Windy Arbor Road for a distance of approximately 150 metres in a north-westerly direction to a point opposite the boundary fence between No. 43 and 45 *Greenes Road*, at its junction with *Pottery Lane*; and

(ii) the northerly side of the access road on the southerly side of *Greenes Road* between premises numbered 3 and 13 *Greenes Road*, a length of approximately 35 metres; and

(2) between the hours 8 a.m. to 6 p.m., 15 minutes in every hour, Monday to Saturday inclusive on:

(i) the southerly side of the access road on the southerly side of *Greenes Road*, between the premises numbered 3 and 13 *Greenes Road*, a length of approximately 38 metres; and

(ii) the layby on the northerly side of *Greenes Road*, between the premises numbered 4 and 10 *Greenes Road*, a length of approximately 30 metres; and

(b) the following sections of existing Traffic Regulation Orders will be revoked:

(1) The Council of the Borough of Knowsley (Various Roads) (Restriction of Waiting) (No. 1) Order 1975, Prohibition of Waiting 'At Any Time' comprising:

Greenes Road, along both sides from its junction with Windy Arbor Road for a distance of approximately 150 metres in a north-westerly direction to a point opposite the boundary fence between No. 43 and 45 *Greenes Road*, at its junction with *Pottery Lane*;

(2) The Council of the Borough of Knowsley (Various Roads) (Restriction of Waiting) (No. 1) Order 1975, Prohibition of Waiting, 8 a.m. to 6 p.m. except Sundays. 1 hour in every 2 hours only, comprising:

(i) the northerly side of the access road on the northerly side of *Greenes Road* between premises numbered 2 and 18 *Greenes Road*, a length of approximately 70 metres; and

(ii) the southerly side of the access road on the southerly side of *Greenes Road* between premises numbered 3 and 13 *Greenes Road*, a length of approximately 45 metres; and

(3) The Council of the Borough of Knowsley (*Greenes Road, Whiston*) (Prohibition of Waiting) Order 1988. Prohibition of Waiting 'At any time', comprising:

(i) the southerly side of the access road on the northerly side of *Greenes Road* between premises numbered 2 and 18 *Greenes Road*, a length of approximately 70 metres; and

(ii) the northerly side of the access road on the southerly side of *Greenes Road* between premises numbered 3 and 13 *Greenes Road*, a length of approximately 33 metres.

3. Exemptions to 2(a) above, will allow waiting:

- (a) to enable a person to board or alight from a vehicle;
- (b) for a period not exceeding three hours in every four hours by a disabled person's vehicle displaying a Disabled Person's Badge;
- (c) to enable goods to be loaded onto or unloaded from a vehicle; and in conjunction with:
 - (d) statutory power and duties;
 - (e) collection and delivery of postal packets;
 - (f) the maintenance of the roads and services therein;
 - (g) buildings operations; and
 - (h) supplying gas, electricity and water.
