## MANCHESTER CITY COUNCIL

### *City of Manchester (Seymour Road South and North Road, Clayton) (Prohibition of Waiting) Order 1993*

## NEW ROADS AND STREET WORKS ACT

### AVON COUNTY COUNCIL

#### NEW ROADS AND STREET WORKS ACT 1991

##### *Restriction of Works Following Substantial Roadworks*

In accordance with section 58 of the New Roads and Street Works Act 1991 ("the Act"), Avon County Council as Street Authority gives three months' notice of its intention to carry out substantial road works as detailed below.

2. The works are located on the A432 Badminton Road from Beesmoor Road, Coalpit Heath (O.S. Grid Ref. ST673 806) to Coalsack Lane, Kendleshire (O.S. Grid Ref. ST663 794).

3. The works comprise approximately 18,000 square metres of resurfacing to the whole carriageway width between Beesmoor Road and Coalsack Lane.

4. The works will commence on or within 1 month of 1st September 1993.

5. Subject to the exemptions in the Act and the Regulations under it, no street works may be executed in the length of the highway described in paragraph 2 above without the consent of Avon County Council for a period of 12 months following the completion of the works described above.
