

## DERBYSHIRE COUNTY COUNCIL

## NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

*Notice of Substantial Road Works*

Three months' advance notice is hereby given that Derbyshire County Council intends to carry out substantial works for road purposes.

2. The site in which these works will take place is located off Wyvern Way on the Wyvern Development south of the A52 Principal Road approximately 1.5 kilometre east of Derby.

3. Works are expected to affect the carriageway/footway/footpath/verge between points on Wyvern Way approximately 120 metres in either direction from the centre of "Toys R Us" service entrance.

4. Work is expected to commence on Monday, 9th September 1993.

5. The works notified will include the following:

A three-span continuous steel/concrete composite deck spanning the River Derwent and supported on piled foundations, a reinforced concrete vehicular underpass and a large roundabout and associated roadworks, drainage and signing. Estimated value £3.2 million.

6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 12 months from completion of the works described in paragraph (5) without the consent of the said Derbyshire County Council which shall not be unreasonably withheld.

2. The works are located at Ludlow Close in the Parish of Warminster starting at O.S. Grid Ref. ST 868 439, junction of Deverill Road to the end of the Estate Road, for a maximum distance of 610 metres.

3. The works comprise full width footway reconstruction to a depth of 175 millimetres with patching in front of renewed kerbs.
