# WATER RESOURCES ACT

Notice of application for a combined licence to obstruct or impede the flow of an inland water by means of impounding works and to abstract water.

## DONCASTER BOROUGH COUNCIL

The Doncaster Borough Council South Yorkshire County Council (Various Roads, Armthorpe and Edenthorpe) (Traffic Regulation Consolidation) Order 1980 (Amendment No. 7) Order 1993.

Notice is hereby given that on 9th June 1993 the Doncaster Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 23rd June 1993 will be to prohibit the driving of vehicles (except for pedal cycles) in that length of Hatfield Lane, Edenthorpe from its junction with Thorne Road (A18) for a distance of 30 metres in a southerly direction.

## GLOUCESTER CITY COUNCIL

The City of Gloucester (Theresa Street) (Traffic Regulation) (Consolidation and Amendment) Order 1993

Notice is hereby given that the Gloucester City Council, exercising the undermentioned powers of the Gloucestershire County Council under arrangements made pursuant to section 101 of the Local Government Act 1972, made an Order under sections 1(1), 2(1), (2) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of the Order will be:

- (a) to prohibit the waiting of vehicles at all times in certain lengths of Theresa Street.
- (b) to make Theresa Street between its junctions with Alma Terrace and Bristol Road into a one-way street, with vehicles allowed to proceed only towards Bristol Road.
- (c) to prohibit the driving of vehicles at all times in certain lengths of Theresa Street.

Exceptions are contained in the Order to enable a vehicle to wait upon the direction or with the permission of a police constable in uniform or traffic warden or for so long as may be necessary for a person to board or alight from the vehicle or to enable goods to be loaded onto or unloaded from the vehicle, or to enable the vehicle to be used in connection with any wedding, furneral, building operation or demolition, the removal of any obstruction to traffic and the maintenance of any of the lengths of road or the services therein. An exception is also provided for the vehicle used in the service of a local Authority in pursuance of statutory powers or duties. A further exception is provided to the waiting regulations in the case of a disabled person's vehicle. A further exception is provided to the loading/unloading prohibition(s) in connection with a vehicle in actual use for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.

A copy of the Order together with a map showing the effects of the Order, may be seen at the office of the City Planning and Technical Services Officer, Herbert Warehouse, Gloucester Docks, Gloucester or The North Warehouse, The Docks, Gloucester, from Mondays to Fridays during normal office hours.

The Order comes into operation on 21st June 1993.

Any wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks from 21st June 1993, apply to the High Court for this purpose.
