UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of Oxford University on 2nd June, amending Statute XV has been substituted for approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The Statute redefines the terms of the Rawnsley studentships following the division of the former Czechoslovak Socialist Republic. (18 SI)

ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A458/A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting) (Variation) Order 1989 (Revocation) Order 199 .

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 124 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to revoke the Trunk Road (A458/A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting) (Variation) Order 1989, the provisions of which have been superseded by those of the Trunk Roads (A458) and (A483) (Welshpool, Powys) (Prohibition and Restriction of Waiting and Prohibition of Loading and Unloading) Order 1993.

A copy of the proposed Order, the Order being revoked, together with a plan and a statement of reasons for the making of the Order, may be inspected during normal office hours at the offices of Montgomeryshire District Council, Seven Road, Welshpool, Powys, during a period of 21 days from 19th June 1993.

Objections, specifying the grounds on which they are made and quoting reference ZC 510-2-6-46, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 10th July 1993. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any grounds of objection or

representation may be communicated to other people who may be affected by it.
