PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Texaco North Sea UK Company, whose address is 1 Westferry Circus, Canary Wharf, London E144HA, for the construction of a 6 inch pipe-line between subsea well 13/22a-10 and the loading tanker "Tove Knutsen" via the semi-submersible production unit "John Shaw".

Except with the consent of the Secretary of State, the pipe-line shall only used to convey crude oil and diesel oil.

The pipe-line may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Proposed Stopping-up of a Highway at Manchester
