NEW ROADS AND STREET WORKS ACT 1991

Restriction of works following substantial roadworks

In accordance with section 58 of the New Roads and Street Works Act 1991 ("the Act"), Avon County Council as Street Authority gives three months notice of its intention to carry out substantial road works as detailed below.

2. Location and description of works:

- (i) Tower Road South, Cowhorn Hill and West Street, Oldland from the Junction of Tower Lane to the Junction of A4175. Carriageway resurfacing works.
- (ii) Beckspool Road, Frenchay from the Junction of the B4058 to the River Frome. Carriageway resurfacing works.
- (iii) Goose Green and Webbs Heath, Siston from the Junction of Carson's Road to the Junction of Siston Lane. Carriageway resurfacing works.
- (iv) Webbs Heath, Siston from the Junction of the A420 to the Junction with Siston Lane. Carriageway resurfacing works.
- (v) A38 Gloucester Road, Almondsbury from M5 Interchange to Florence Park. Carriageway resurfacing works.
- (vi) Little Bristol Lane, Charfield from the Junction with the B4058 to the new Crest Homes Development. Carriageway resurfacing works.
- (vii) Kenilworth Drive, Willsbridge from the Junction with the A431 to the Junction of Harlech Way. Carriageway resurfacing works.
- (viii) Carsons Road, Mangotsfield from Goose Green to the incinerator. Carriageway resurfacing works.

3. The works to items 2(i) to 2(iv) inclusive will commence on or within one month of 13th September 1993. The works to items 2(v) to 2(viii) inclusive will commence on or within one month of 1st October 1993.

4. Subject to the exemptions in the Act and Regulations under it, no street works may be executed in the length of the highway described in paragraphs 2(i) to 2(viii), above without the consent of Avon County Council for a period of 12 months following the completion of the works described above.

- (i) A367 Dunkerton Hill, Peasedown St John from the Prince of Wales Public House to 150 metres north of Dunkerton Bridge. Carriageway regulating and resurfacing works. (Ref. NRSWA/S58/7)
- (ii) A362 Farrington Fields from Old Mills to Farrington Gurney Village. Carriageway resurfacing works. (Ref. NRSWA/S58/8)
- (iii) A368 from Chelwood Village to Hunstrete Hill. Carriageway resurfacing works. (Ref. NRSWA/S58/10)
- (iv) A368 from Hunstrete Hill to Junction with A39, Marksbury. Carriageway resurfacing works. (Ref. NRSWA/S58/11)
- (v) A368 from Junction at Stanton Drew to Junction with A37 at Chelwood Bridge. Carriageway resurfacing works. (Ref. NRSWA/S58/12)
- (vi) A367 Fosseyway South, Radstock from County Boundary to Charlton Lane Roundabout. Carriageway resurfacing works. (Ref. NRSWA/S58/13)
- (vii) B3115 North Road, Timsbury from Junction of Bloomfield Road to Junction with Lansdown View. Footway works and Carriageway resurfacing works. (Ref. NRSWA/S58/17)
- (viii) B3116 Wellsway, Burnett near Keynsham from Gipsy Lane to Burnett Village. Carriageway resurfacing works. (Ref. NRSWA/S58/18)
- (ix) Northmead Road, Midsomer Norton from Paulton Road & Northmead Road mini roundabout to Junction north of Wellow Brook Bridge. North Road, Midsomer Norton from Church Lane to junction of Northmead Road & Paulton Road. Carriageway resurfacing works. (Ref. NRSWA/S58/19)

- (x) Woollard Lane, Whitchurch from Junction with A37 to Junction of Charlton Fields. Carriageway resurfacing works. (Ref. NRSWA/S58/20)
- (xi) B3110 Hinton Charterhouse from South of Hinton Charterhouse Village for a distance of approx' 600 metres towards Norton St Phillip. Carriageway resurfacing works. (Ref. NRSWA/S58/21)

3. The works will commence on or within one month of 1st October 1993.

4. Subject to the exemptions in the Act and the Regulations under it, no street works may be executed in the length of the highway described in paragraphs 2(i) to 2(xi), above without the consent of Avon County Council for a period of 12 months following the completion of the works described above.
