Town and Country Planning Act 1990

The Stopping-up of Highways (Railway Terrace, Riverside, Cardiff, South Glamorgan) Order 1993

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this notice to enable the development of residential properties, for which planning permission has been granted to be carried out.

Copies of the made Order and the relevant plan may be inpsected during normal office hours at the offices of Cardiff City Council, City Planning and Development Offices, Wood Street, Cardiff, or may be obtained, free of charge, on application to the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, (quoting ref. ZC510-5-7-21).

If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planing Act 1990; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may, within 6 weeks of 24th June 1993, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

The highway to be stopped up is at Riverside, Cardiff, in the County of South Glamorgan. It is shown by zebra hatching on the deposited plan and is that irregular shaped area of highway land of approximately 485 square metres which lies between Railway Terrace and the rear of those properties known as 84-92 Albert Street. TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Henllys, Cwmbran, Gwent) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 248 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highways described in the Schedule to this notice to facilitate the movement of traffic on the main highway, which is a highway to be constructed in accordance with planning permission granted under appeal on 13th October 1989.

During the 28 days from 24th June 1993, copies of the draft Order and the annexed plans may be inpsected at all reasonable hours at the offices of Gwent County Council, County Hall, Cwmbran, Gwent, and may also be obtained, free of charge, from the address, and quoting the reference, below.

Within the above-mentioned period of 28 days any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, (quoting ref. ZC 510-5-3-20), object to the making of the Order. In the preparation of an objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

(all distances are approximate)

The lengths of highway to be stopped up are at Henllys, Cwmbran, in the County of Gwent. They are shown by zebra hatching on annexed plan A and comprise:

(i) That length of Henllys Village Road which extends from its junction with the road known as Longhouse Grove in a westerly direction for a distance of 80 metres on its southern side and 50 metres on its northern side.
