LIEUTENANCY OF THE CITY OF EDINBURGH

Notice of the Issue of a Submarine Pipe-Line Works Authorisation

With the approval of Her Majesty The Queen, a Commission as a Deputy Lieutenant of the City of Edinburgh with effect from 6th May 1993 has been granted to:

Councillor Mrs. Eleanor T. McLaughlin, 28 Oxbgangs Green, Edinburgh EH13 9JS, on the recommendation of the Right Honourable Norman Irons, Lord Provost and Lord Lieutenant. (271)

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Kerr McGee Oil (U.K.) Plc, whose address is 75 Davies Street, London W1Y 1FA, for the construction of a 6-inch production pipe-line, a 6-inch gas cap production/injection pipe-line, a 10-inch aquifer production pipe-line, an 8-inch water injection pipe-line, for gas lift umbilicals and two chemical injection umbilicals between the Floating Production Storage and Offloading vessel Gryphon "Alpha" and the subsea wellhead cluster in Block 9/18b.

Except with the consent of the Secretary of State, the pipe-lines shall only be used to convey oil, gas, water and lift gas in the case of one of the 6-inch pipelines, gas cap and reinjection gas in the case of the other 6-inch pipe-line, aquifer water and lift gas in the case of the 10-inch pipe-line, aquifer water and produced water in the case of the 8 inch pipe-line, lift gas in the case of the four gas lift umbilicals and scale inhibitor, demulsifier and methanol in the case of the two chemical injection umbilicals.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Kerr McGee Oil (U.K.) Plc has been appointed operator of the pipe-lines.
