Bedfordshire County Council propose to vary the waiting restriction in Church Street, Biggleswade

Notice is hereby given that Bedfordshire County Council proposes making a road traffic regulation Order.

The effect of the Order will be to vary the County of Bedfordshire (Various Roads, Biggleswade) (Prohibition and Restriction of Waiting) Order 1979:

- (i) Schedule 1, paragraph 3, shall be deleted and the following substituted:
"3. Church Street, south side from its junction with Shortmead Street eastwards for 26.6 metres."
- (ii) Schedule 1, paragraph 3, additional paragraph to be inserted as follows:
"North side from a point 23 metres west of the junction with Rose Lane in a westerly direction for 17.3 metres."
- (iii) Schedule 2, item 3c, shall be deleted and the following substituted:
"North side from its junction with Rose Lane westwards for 23 metres."
- (iv) Schedule 2, paragraph 3, additional paragraph to be inserted as follows:
"South side from a point 78.6 metres east of the junction with Shortmead Street in an easterly direction for 28.4 metres."
- (v) Schedule 3, paragraph 1, shall be deleted and the following shall be substituted:
"South side from a point 26.6 metres east of the junction with Shortmead Street eastwards for 52 metres."
"South side from a point 107 metres east of the junction with Shortmead Street eastwards for 28 metres."
"North side from a point 155 metres east of the junction with Shortmead Street eastwards to a point 40.3 metres west of Rose Lane."

The effect of these alterations in Church Street, Biggleswade, is as follows:

- (a) To impose a Monday to Saturday 8 a.m. to 6 p.m. restrictions on a 28-metre length of Church Street opposite Chapelfields, in place of a section of the existing limited waiting.
- (b) To impose a no waiting at any time on the eastern entrance to the Greene King site, which is designated as an emergency entrance to the entire site.
- (c) To slightly extend the no waiting at any time restriction on the south side of the western end of Church Street.
