Whereas We consider it desirable that Tuesday, the twenty-eighth day of December in the year 1993, and Monday, the third day of January and Monday, the second day of May in the year 1994, should be bank holidays in England, Wales and Northern Ireland:

And whereas We consider it desirable that Monday, the twenty-seventh day of December and Tuesday, the twenty-eighth day of December in the year 1993, and Tuesday, the fourth day of January and Monday, the thirtieth day of May in the year 1994, should be bank holidays in Scotland:

Now, therefore, We, in pursuance of section 1(3) of the Banking and Financial Dealings Act 1971, do hereby appoint Tuesday, the twenty-eighth day of December in the year 1993, and Monday, the third day of January and Monday, the second day of May in the year 1994 to be bank holidays in England, Wales and Northern Ireland and Monday, the twenty-seventh day of December and Tuesday, the twenty-eighth day of December in the year 1993, and Tuesday, the fourth day of January and Monday, the thirtieth day of May in the year 1994, to be bank holidays in Scotland.

Given at Our Court at Buckingham Palace this twenty-third day of June in the year of our Lord one thousand nine hundred and ninety-three and in the forty-second year of Our Reign.
