TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Minafon, Bangor, Gwynedd) Order 1993

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this Notice to enable development consisting of a car parking facility, for which planning permission has been granted, to be carried out.
