#### **TOWN AND COUNTRY PLANNING ACT 1990**

Stopping-up of a highway at Birkenhead

The Secretary of State for Transport hereby gives notice that on the application of Wirral Metropolitan Borough Council he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (Metropolitan Borough of Wirral) (No. 2) Order 1993" authorising the stopping-up of part of Neston Gardens, Birkenhead, from its junction with Beckwith Street to its junction with Prince Street.

#### **HIGHWAYS ACT 1980**

The A660 Trunk Road (Kings Road Junction Improvement Side Roads) Order 1993

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 14 and 125 of the Highways Act 1980, in relation to the A660 Trunk Road at Golden Acre Corner at Bramhope, Leeds, in the county of West Yorkshire. The Order is entitled The A660 Trunk Road (Kings Road Junction Improvement Side Roads) Order 1993 and it:

- (1) authorises him to:
  - (a) improve The Sycamores and Kings Road;
  - (b) stop up a length of The Sycamores and Kings Road;
  - (c) to construct new highways:
    - (i) to connect The Sycamores with the Trunk Road;
    - (ii) to provide a new bridleway along the stopped-up section of The Sycamores;
  - (d) stop up private means of access to premises and;
  - (e) provide new means of access to premises.

all at Golden Acre Corner, Bramhope, on or in the vicinity of the route of trunk road mentioned above; and

(2) provides for the transfer of the new highways to Leeds City Council as highway authority from the date on which he notifies them that it has been completed and is open for traffic.

Any person aggrieved by the Order who desires to question its validity, or the validity of any provision in it, on the ground that:
