TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of an unnamed back lane at the rear of 39 Elton Parade, Darlington, County Durham.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Mr. M. Clemmet, by Darlington Borough Council on 18th November 1992, under reference 8/92/571/DM.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during the 28 days commencing on 19th July 1993 at the offices of Darlington Borough Council, Town Hall, Darlington, County Durham, and may be obtained free of charge from the Department of Transport (quoting reference DN 5053/35/1/252) at the address below.

ROAD TRAFFIC REGULATION ACT 1984

The A5092 Trunk Road (Lowick, South Lakeland) (Variable Speed Restriction) Order 1993

Notice is hereby given that the Secretary of State for Transport has made an Order under section 84(1), (1a) and (2) of the Road Traffic Regulation Act 1984. The effect is to restrict the speed limit to 30 m.p.h. on the A5092 between a point 72 metres west and 150 metres east of its junction with the U5083, Lane End at Lowick in South Lakeland, Cumbria. The restriction will only be in force between the hours of 8 a.m. to 9 a.m. and 3 p.m. to 4 p.m. on Mondays to Fridays inclusive. At all other times, the national limit of 60 m.p.h. will apply.
