#### TOWN AND COUNTRY PLANNING ACT 1990

*The Stopping-up of Highways (Morfa Drive, Conwy, Gwynedd)  
Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping up of the highway described in the Schedule to this notice to enable residential

development, for which planning permission has been granted, to be carried out.

During the 28 days from 22nd July 1993 copies of the draft Order and the annexed plan may be inspected during normal office hours at the offices of Aberconwy Borough Council, Council Offices, Bodlondeb, Conwy, Gwynedd, or may be obtained free of charge from the address and quoting the reference shown below.

Within the above-mentioned period of 28 days, any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. ZC 510-5-4-9) object to the making of the Order. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

#### SCHEDULE

The highway to be stopped is at Conwy in the County of Gwynedd. It is shown by zebra hatching on the annexed plan and is that length of highway known as Morfa Drive which extends from a point 53 metres north-east of the centreline of its junction with the access road to the Sandpipers Estate for a distance of 31 metres in a north-easterly direction then continuing for a distance of 93.5 metres in a north-westerly direction.
