UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of Corpus Christi College, in the University of Oxford on 13th July 1993, amending Statute III has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The purpose of this Statute is to remove the right of visiting scholars to receive free common meals and the possibility of being allotted a room in the College. (4 SI)
