SCHEDULE 2

Residents Only Parking At Any Time.

King Edward Road, north side.

- (a) Between points 20 metres (approximately) and 50 metres (approximately) west of the western kerb-line of Rhyddings Park Road.
- (b) Between points 40 metres (approximately) and 64 metres (approximately) east of the eastern kerb-line of Rhyddings Park Road.
- (c) Between points 7 metres (approximately) and 37 metres (approximately) west of the western kerb-line of Bay View Crescent.
- (d) Between points 50 metres (approximately) and 75 metres (approximately) east of the eastern kerb-line of Bay View Crescent.
- (e) Between points 100 metres (approximately) and 124 metres (approximately) east of the eastern kerb-line of Bay View Crescent.
- (f) Between points 140 metres (approximately) and 158 metres (approximately) east of the eastern kerb-line of Bay View Crescent.

Limited Waiting 8 a.m. to 6 p.m. Monday to Saturday. 1 hour No Return for 2 hours.

Residents with Valid Permit Exempt.

King Edward Road, north side. Between points 10 metres (approximately) and 60 metres (approximately) west of the western kerb-line of Bryn-y-Mor Road.

SCHEDULE 3

Limited Waiting 1 hour No Return for 2 hours with Exemption For Residents Obtaining and Displaying a Valid Parking Permit.

Dunns Lane, Mumbles, north side.

- (a) Between points 45 metres (approximately) and 57 metres (approximately) west of the western kerb-line of Mumbles Road.
- (b) Between points 65 metres (approximately) and 80 metres (approximately) west of the western kerb-line of Mumbles Road.
- (c) Between points 96 metres (approximately) and 102 metres (approximately) west of the western kerb-line of Mumbles Road.
- (d) Between points 108 metres (approximately) and 114 metres (approximately) west of the western kerb-line of Mumbles Road.

SCHEDULE 4

Partial Revocation of the Swansea (West Central Area) (Street Parking Places) Order 1969

Oxford Street, north side, that length of highway between its junction with Wyndham Street and Dillwyn Street.

Introduction of Limited Waiting (1 Hour No Return for 2 Hours, Monday to Saturdays, 8 a.m. to 6 p.m. with Exception for Residents Displaying Valid Parking Permit) Order 1993.

Oxford Street, north side, between points 13 metres (approximately) and 87 metres (approximately) east of the eastern kerb-line of Wyndham Street.

Eversley Road, Sketty; Vivian Road, Sketty, City of Swansea (Restriction of Waiting) Order 1970.

Residents being allowed to park for an indefinite time providing a valid permit is displayed.

SCHEDULE 7

Partial Revocation of the City of Swansea (Bryn-y-Mor Road, St. Helens Road, Oxford Street) (Limitation of Waiting) (Variation) Order 1972.

Bryn-y-Mor Road, north side, between points 20 metres (approximately) and 43 metres (approximately) east of the eastern kerb-line of Westbury Street.

SCHEDULE 8

Limited Waiting Order

1 Hour Limited Waiting No Return for 2 hours, Monday to Saturday, 8 a.m. to 6 p.m. with exemption for Residents Displaying a Valid Permit.

Galmorgan Street, Sandfields, Swansea, east side, between points 15 metres (approximately) and 108 metres (approximately) north of the northern kerb-line of Oystermouth Road.

St. Helens Avenue:

South side, between points 75 metres (approximately) and 122 metres (approximately) west of the western kerb-line of St. Helens Road.

North side, between points 23 metres (approximately) and 97 metres (approximately) east of the eastern kerb-line of Catherine Street.

(b) *From a point directly opposite the western kerb-line of Dan-y-Parc and 83 metres (approximately) westwards, for a distance of 2 metres (approximately).*

South side.

(a) *From the eastern kerb-line of Dan-y-Parc, eastward for a distance of 5 metres (approximately).*

(b) *From the western kerb-line of Dan-y-Parc, westward for a distance of 4 metres (approximately).*

(c) *From a point 82 metres (approximately) west of the western kerb-line of Dan-y-Parc, westwards a distance of 4 metres (approximately) continuing transversely across the head of the cul-de-sac for a distance of 7 metres (approximately).*

No Waiting at Any Time

Dan-y-Parc, Morriston.

West side, from the southern kerb-line of Harry Street, southwards for a distance of 5 metres (approximately).

East side, from the southern kerb-line of Harry Street, southwards for a distance of 5 metres (approximately).
