The Borough of Kettering (Princes Street, Kettering) (Prohibition of Waiting) Order 1993

Notice is hereby given that further to the notice which appeared in *The London Gazette* on 7th September 1992 under reference 763 Kettering Borough Council, as agent for the Northamptonshire County Council, has made an Order pursuant to sections 1, 2(1), (2) and 4 of the Road Traffic Regulation Act 1984, as amended. The effect of the Order is to introduce an area of no waiting at any time on the northern side of Princes Street to allow safe entrance to and exit from business premises.

Exemptions to the Order will permit waiting for the purpose of the removal of any obstruction to traffic and where necessary in connection with the maintenance of roads and the supply of gas, water, electricity and telecommunications and for emergency services.

The Order also contains an exemption for disabled persons' vehicles bearing the relevant orange badge.

A copy of the Order, together with a plan showing the length of road to which the Order relates and a statement of the Council's reasons for making the Order, may be inspected at the offices of the Borough Solicitor between the hours of 9 a.m. to 12.30 p.m. and 2 p.m. to 5 p.m., Mondays to Fridays inclusive.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the ground that any requirement of the Act or any Instrument made under it has not been complied with, you may, within 6 weeks of the date of this notice, apply to the High Court for this purpose.

This Order shall come into force on 2nd August 1993.

The Borough of Kettering (Crown Street, King Street, Princes Street, Kettering) (Prohibition of Waiting and One-way Traffic) Order 1993.

Notice is hereby given that further to the notice which appeared in *The London Gazette* on 15th November 1991 under reference 790 Kettering Borough Council, as agent for the Northamptonshire County Council, has made an Order pursuant to sections 1, 2(1), (2) and 4 of the Road Traffic Regulation Act 1984, as amended. The effects of the Order will be to make parts of Crown Street, King Street and Princes Street one-way streets and to introduce areas of no waiting at any time to facilitate the free flow of traffic.

Exemptions to the Order will permit waiting for the purpose of the removal of any obstruction to traffic and where necessary in connection with the maintenance of roads and the supply of gas, water, electricity and telecommunications and for the emergency services.

The Order also contains an exemption to the waiting restrictions for disabled persons' vehicles bearing the relevant orange badge.

A copy of the Order, together with a plan showing the lengths of road to which the Order relates and a statement of the Council's reasons for making the Order, may be inspected at the offices of the Borough Solicitor between the hours of 9 a.m. to 12.30 p.m. and 2 p.m. to 5 p.m., Mondays to Fridays inclusive.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with, you may, within 6 weeks of the date of this notice, apply to the High Court for this purpose.

This Order shall come into force on 2nd August 1993.

NOTTINGHAMSHIRE COUNTY COUNCIL

The Nottinghamshire County Council (Gedling Road, Carlton) (Prohibition of Waiting) Order 1993 (7000)

Notice is hereby given that the Nottinghamshire County Council proposes to make an Order under section 1 of the Road Traffic Regulation Act 1984, as amended, the effects of which will be:

Vehicles will be prohibited from waiting at any time in the following length of road at Carlton in the Borough of Gedling.

Gedling Road, south-east side, from its junction with Blackhill Road in a south-westerly direction for a distance of 15 metres.

The usual exemptions will be provided. Relevant documents may be inspected at my office or at the Carlton Library, Manor Road, Carlton, Nottingham. Written objections (stating grounds and quoting ref. 7000) must be received by me by the 30th August 1993.

The prohibition is intended to improve visibility for drivers turning out of Blackhill Drive into Gedling Road.

ROCHDALE BOROUGH COUNCIL

The Metropolitan Borough of Rochdale (Buckley Hill Lane and The Cray, Milnrow) (Prohibition of Waiting) Order 1993

Notice is hereby given that the Rochdale Borough Council in exercise of its powers under section 1 of the Road Traffic Regulation Act 1984, intend to make an Order the effect of which would be to prohibit waiting at any time on:

(a) *Buckley Hill Lane:*

(i) Westerly side from a point 15 metres south-west of its junction with The Cray to a point 15 metres north-east of its junction with The Cray;

(ii) Easterly side (1) from its junction with Bramhall Close for a distance of 97 metres in a north-easterly direction and (2) from a point 102 metres north-east of its junction with Bramhall Close for a distance of 27 metres in a north-easterly direction.

(b) *The Cray:*

(i) Northerly side from its junction with Buckley Hill Lane for a distance of 15 metres in a westerly direction;

(ii) Southerly side from its junction with Buckley Hill Lane for a distance of 42 metres in a westerly direction.

The proposed Order would contain certain exemptions relating to emergency vehicles and statutory undertakers, disabled persons, loading and unloading, persons boarding and alighting from vehicles.

A copy of this Order and a map showing the length of road concerned may be inspected at the Information Office, 2nd Floor, Municipal Offices, Smith Street, Rochdale, between the hours of 9.30 a.m. to 12.30 p.m., and 2 p.m. to 4.45 p.m., Mondays to Fridays inclusive.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 31st July 1993, apply to the High Court for this purpose.

The Order will come into effect on Monday, 2nd August 1993.
