Notice is hereby given that Sedgefield District Council has determined that the areas described in the Schedule below are areas of special architectural or historic interest, the character or appearance of which it is desirable to preserve or enhance and has accordingly designated the areas as: Brusselton Conservation Area, Cornforth Conservation Area, Hardwick Park Conservation Area, Kirk Merrington Conservation Area, Mainsforth Conservation Area, Middridge Conservation Area, Mordon Conservation Area, Shildon Conservation Area, Trimdon Village Conservation Area, Whitworth Conservation Area and Windlestone Conservation Area.

The designation of the area as conservation areas means that buildings within the conservation areas may not be demolished without the consent of Sedgefield District Council, and trees within

the area may not be cut down, topped, lopped, uprooted or wilfully damaged in any way without the consent of Sedgefield District Council. Planning applications for development which are considered by Sedgefield District Council to affect the character or appearance of the conservation area will be subject to public consultation and any representations received will be taken into account before the applications are determined.
