The County of Devon (Caroline Place Area, Plymouth) (Residents' Parking Places and Prohibition and Restriction of Waiting, Oneway Traffic and Prohibition of Driving) Amendment Order 1993.

Notice is hereby given that the Devon County Council propose to make an Order under sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be:

- (a) To provide for "residents only" and "essential visitors" parking by permit between the hours of 8 a.m. and 6 p.m. Monday to Friday on parts of the roads specified in Schedule 1 to this notice for residents or businesses whose usual residence or business address is at premises contained within the defined boundary area as set out in Schedule 2 to this notice. The criteria for an "essential visitors" permit is as defined in the proposed Order.
- (b) The charge for an "essential visitors" and "resident's permit" will be £10 per annum and a "resident's business permit" will be £10 per annum for the first permit, £20 per annum for the second permit and thereafter increasing by £10 per permit. The aforementioned charges may be varied by a Minute of the Highways and Transportation Committee of the Devon County Council.
- (c) To prohibit the waiting of vehicles at any time on parts of the roads specified in Schedule 3 to this notice.
- (d) To prohibit the waiting of vehicles for more than 1 hour in any 4 hours, Monday to Friday between the hours of 8 a.m. to 6 p.m. on parts of the road specified in Schedule 4 to this notice.
- (e) No person shall cause or permit any vehicle to proceed in the lengths of road specified in Column 1 of Schedule 5 to this notice in a direction other than that specified in relation to that road in Column 2 of that Schedule.
- (f) To prohibit the driving of motor vehicles at any time on the lengths of road specified in Schedule 6 to this notice.
- (g) To revoke some Orders in their entirety and to amend and revoke parts of other Orders full details of which are contained in the proposed Order.

With regard to paragraph (a) there is contained in the proposed Order details setting out restrictions of use of vehicles at parking places and general exceptions as to restrictions of waiting of vehicles in parking places.

With regard to paragraphs (c) and (d) exceptions will be provided in the proposed Order permitting waiting for the purposes of boarding and alighting, loading and unloading, building and demolition, roadworks, the maintenance of essential services and for disabled persons' vehicles being used in accordance with the Orange Badge Scheme.
