TAMESIDE METROPOLITAN BOROUGH COUNCIL

The Tameside Metropolitan Borough Council (Penny Meadow, Albion Street, Cowhill Lane) (Prohibition and Restriction of Waiting) Order 1992.

Notice is hereby given that the Tameside Metropolitan Borough Council have made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, and all other enabling powers, the effect of which is to amend the existing restrictions on Penny Meadow and introduce restrictions on Albion Street and Cowhill Lane. WILTSHIRE COUNTY COUNCIL

The County of Wiltshire (A345 Pewsey Road, Upavon) (Restricted Roads) Order 1993

NORTH YORKSHIRE COUNTY COUNCIL

NORTH YORKSHIRE COUNTY COUNCIL

The North Yorkshire County Council (Prohibition of Heavy Commercial Vehicles (C67 Maltongate, Thornton-le-Dale) Order 1993.
