A6069, Broughton Road (Principal Road), north side, from a point 129-8 metres east of its junction with Carleton New Road, measured from the centre-line of Carleton New Road, eastwards for a distance of 125-2 metres.

A6060, Belmont Street/Brougton Road (Principal Road), south side, from a point 21 metres west of its junction with Cavendish Street measured from the centre-line of Cavendish Street, westwards for a distance of 314 metres.

Belmont Wharf (Unclassified County Road), both sides, from its junction with Swadford Street, northwards for a distance of 53 metres measured from the centre-line of Swadford Street.

The North Yorkshire County Council (Prohibition and Restriction of Waiting and Disc Parking) (Various Roads, Northallerton) (Consolidation) Order 1993.

Notice is hereby given that on 28th July 1993, North Yorkshire County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which will be to:

- (a) Revoke various Prohibition and Restriction of Waiting Orders relating to Northallerton and re-introduce them as a Consolidation Order.
- (b) Prohibit the waiting of vehicles between the hours of 9 a.m. and 5 p.m., Monday to Friday in Racecourse Lane on both sides from its junction with South Parade/Boroughbridge Road for a distance of 293 metres measured from the projected centreline of South Parade/Boroughbridge Road.
- (c) Re-define the areas to be used as parking places Monday to Saturday on the north side of Zetland Street from a point 82.5 metres west of its junction with East Road westwards for a distance of 7.5 metres and from 98 metres west of its junction with East Road, westwards for a distance of 6.5 metres.

Waiting restrictions on Lynton Way, Northallerton are not included in this Order.
