The Norfolk County Council (Miscellaneous) (40 and 50 m.p.h. Speed Limit) Consolidation Order 1993

Notice is hereby given that the Norfolk County Council has made an Order under the Road Traffic Regulation Act 1984, the effect of which will be to prohibit any vehicle from exceeding 40 m.p.h. on any road specified in Schedule 1 below, and from exceeding 50 m.p.h. on any road specified in Schedule 2 below.

This consolidation Order reproduces the provisions of the following Orders or part Orders.

Any person who desires to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, may within 6 weeks from 9th August 1993 apply to the High Court for this purpose.

SCHEDULE 1

40 m.p.h. speed limit

In the Parish of Briston

Fakenham Road/Norwich Road B1354; from east side of the junction with The Lane near Manor Farm to a point 50 metres east of its junction with Horseshoe Lane.

In the Parishes of Mulbarton and Swardeston

B1113; from a point 188 metres north-east of junction Catbridge Lane (Mulbarton) north-eastwards to a point 46 metres south-west of junction Wood Lane (Swardeston).

In the Parish of Fritton

New Road; from the A143 northwards for a distance of 620 metres.

In the Parish of South Lopham

B1113 Church Road; from junction A1066 The Street north-west for a distance of 520 metres.

B1113 Redgrave Road; from junction A1066 The Street southwards for a distance of 540 metres.

C145 Blo Norton Road; from junction A1066 Thetford Road south-west for a distance of 160 metres.

In the Parish of Thorpe St. Andrew

B1140, Plumstead Road East; from a point 180 metres to the east of its junction with South Hill Road to a point 230 metres to the east of its junction with Broadland Drive.

Green Lane North, Thorpe End; from its junction with the B1140 to a point 90 metres to the south of Woodland Drive.

Broadland Drive; from Plumstead Road to a point immediately north of its junction with the access road in front of the garage.

B1457, Ring Road; from a point 22 metres east of its junction with Margaret Crescent/Elizabeth Avenue to the A47 Yarmouth Road.

Dussindale Drive; from its junction with the B1457 (Ring Road) to a point 22 metres to the south of its junction with Pound Lane.

In the Parish of Bircham Newton

B1155; from a point 470 metres south-west of its junction with the C92 to a point 120 metres south of its junction with Monks Close (a distance of 860 metres).

C92; from its junction with the B1155 for a distance of 200 metres southwards.

In the Parish of Beetley

Elmham Road; from its junction with the Fakenham Road to its junction with Green Lane.

Fakenham Road (B1146); from a point 133 metres south-east of its junction with High House Road to point 220 metres south-east of its junction with the southern leg of Litcham Road.

In the Parish of Gressenhall

Gressenhall Road; for its entire length.

Litcham Road; from its junction with the Fakenham Road (B1146) to a point 83 metres east with Dodson Drive.

In the Town of Thetford

London Road; from the existing 40 m.p.h. speed limit at its junction with Stephenson's Way to the roundabout on the A11 Thetford Bypass.

In the Parish of Docking

B1454; from a point approximately 290 metres west of its junction with the B1153 (Bircham Road) to a point approximately 345 metres south-east of its junction with the B1155 (Stanhoe Road).

B1153; northwards from its junction with the B1454 (Chequers Street) to a point approximately 340 metres north-east of its junction with Choseley Road.

Choseley Road; from its junction with the B1153 (Brancaster Road) for a distance of approximately 23 metres.

Well Street; for its whole length.

Ringstead Road; from its junction with the B1454 for a distance of approximately 170 metres.

Pound Lane; from its junction with the B1153 for a distance of approximately 245 metres.

In the Parish of Framingham Earl

UC78027 Long Road; from its junction with the B1332 Norwich Road eastwards to its junction with Hall Road.

In the Parish of West Walton

Salts Road (Fen End Lane); from Church Lane to a point 630 metres east of St. Mary's Road.

Salts Road (Wasdyke Lane); from Lynn Road north and west for 580 metres.

Spencer Close; entire length.

St. Mary's Road; entire length.

St. Paul's Road; from Lynn Road south-east for 570 metres.

Common Road; from Lynn Road south-east for 510 metres.

In the Parish of Great Ellingham

Watton Road, Attleborough Road; (B1077); from 300 metres west of Hingham Road to 220 metres south east of Church Street.

Hingham Road; from B1077 northwards for 340 metres including cul-de-sac off this length.

Church Street, Chequers Lane, Chequers Green, Mill Lane; from Chequers Lane south westwards for 180 metres.

Rectory Lane, Home Close, The road towards Morley; from B1077 north eastwards for 50 metres.
