

NOTES

(1) The Animals and Animal Products (Import and Export) Regulations 1992 implements European Community legislation on veterinary checks on animals and certain animal products imported from non-EC countries. Importers are advised to familiarise themselves with the obligations that the Regulations place on them. Information Notes Nos. 1 and 5 (TIS/1 and TIS/5) issued by the Ministry summarise the rules. Copies of these notes may be obtained, on request, from the address below.

(2) Animals will be accepted as Registered if they are accompanied by an identification document issued by the breeding authority which manages the studbook or register for that breed of animal in the country where the animal originated or any international association or organisation which manages horses for competition or racing.

(3) Council Directive 91/496/EEC (as amended) requires that live animals may be imported into the European Community from a non-EC country *only* through an approved Border Inspection Post and undergo veterinary checks before being permitted entry to the Community. In the case of animals destined for Great Britain but which first enter the Community through a Border Inspection Post in another Member State, it is the responsibility of the owner or his representative to obtain prior agreement from

- the official veterinary at the Border Inspection Post of entry, for presentation of the animals at the Border Inspection Post, and
- the veterinary authority of any Member State of transit, for transport of the consignment via its territory.

On arrival at the Border Inspection Post, the owner or representative must present the health certificate to the veterinary inspection staff. The health certificate will be retained at the Border Inspection Post.

The veterinary inspection staff will provide a border crossing certificate, confirming that the veterinary checks have been carried out, and an authenticated copy of the original health certificate. Both documents must accompany the animal on importation into Great Britain.

(4) In the event of the conditions of this licence not being complied with, or there is suspicion of disease, the Ministry has power under the Animals and Animal Products (Import and Export) Regulations

1992 to require the owner or representative to isolate, re-export, or destroy the animal at the expense of the owner or their representative.

By virtue of the provisions of section 9(1) of the City of London (Various Powers) Act 1956, I, the undersigned, Commissioner of Police for the City of London, do hereby appoint a Standing for TWO HACKNEY CARRIAGES at Queen Victoria Street, E.C.4., and do make the following Regulation with regard to the same, viz:

The Standing shall be on the south side of the carriageway, commencing at a point level with the east end of the retaining wall on the footway outside number 165, Queen Victoria Street for a distance eastwards of 10 metres.

Cabs to rank facing west.

By virtue of the provisions of section 9(1) of the City of London (Various Powers) Act 1956, I, the undersigned, Commissioner of Police for the City of London, do hereby appoint a Standing for THREE HACKNEY CARRIAGES at Minories, E.C.3., and do make the following Regulation with regard to the same, viz:

The Standing shall be on the east side of the carriageway, commencing at a point 3 metres south of the south kerb-line of the private road to the north of Tower Gateway Station for a distance southwards of 15 metres.

Cabs to rank facing north.
