NEW ROADS AND STREET WORKS ACT

SALFORD CITY COUNCIL

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

Notice of Substantial Road Works

Three months advance notice is hereby given that Salford City Council (Highway Authority) intends to carry out substantial works for road purposes.

2. The street in which these works will take place is Crowther Gardens Area, Ordsall, Salford.

3. Work is expected to effect the carriageway/footway area outlined on attached plan.

4. Work is expected to commence on 25th October 1993.

5. The works notified will include the following:

(a) Area outlined on attached plan.

(b) Provision of 7 nr. new culs-de-sac with associated drainage and street lighting works together with new footway along the northern side of Crowther Avenue.

6. Subject to the exemptions in the Act and Regulations under it, no street works may be executed on or after the date given in paragraph 4 above without the consent of the said (Highway Authority) which shall not be unreasonably withheld.

PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

Designation of Conservation Areas

Notice is hereby given that the Council of the London Borough of Camden as Local Planning Authority, in pursuance of the powers conferred upon them by section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, has designated areas as extensions to or new conservation areas, being areas of special architectural and historical interest, the character of which are desirable to preserve and enhance.

1. The following new Conservation Areas have been designated:

Holly Lodge Estate including: Bromwich Avenue, Hillway, Holly Lodge Gardens, Langbourne Avenue, Makepeace Avenue, Oakshot Avenue, Robin Grove, and parts of Highgate West Hill and Swains Lane.

West End Green including: Cannon Hill, Cholmley Gardens, Crediton Hill, Fawley Road, Honeybourne Road, and parts of Dennington Park Road, Finchley Road, Inglewood Road, Lymington Road, Lyncroft Gardens, Mill Lane, Parsifal Road, Sandwell Crescent and West End Lane.

Dartmouth Park including: Balmore Street, Bellgate Mews, Bertram Street, Boscastle Road, Bramshill Gardens, Brookfield Park, Chester Road, Chetwynd Road (including Chetwynd Villas), Church Walk, Churchill Road, Colva Walk, Croftdown Road, Dartmouth Park Avenue, Dartmouth Park Road, Doynton Street, Glenhurst Avenue, Grove Terrace Mews, Kingswear Road, Laurier Road, Lissenden Gardens, Lulot Gardens, Raydon Street, Retcar Close, Sandstone Place, Spencer Rise, St. Albans Road, St. Annes Close, Stoneleigh Terrace, Twisden Road, Winscombe Street, Woodsome Road, York Rise (including York Rise Estate), Coutts Crescent, and

parts of Dartmouth Park Hill, Gordon House Road, Highgate Road, Highgate West Hill, Swains Lane.

NOTE: Areas transferred from Highgate CA to Dartmouth Part CA: Grove Terrace, Grove End, Little Green Street, Wesleyan Place, Mortimer Terrace, and parts of Highgate West Hill, College Lane, Highgate Road, Lady Somerset Road.

Bartholomew Estate including: Bartholomew Villas, Hammond Street, Lawford Road, Wolsey Mews, and parts of Bartholomew Road, Busby Place, Caversham Road, Gaisford Street, Islip Street, Osney Crescent, Patshull Road, Sandall Road.

2. The following Conservation Areas have been extended:

Bloomsbury to include: (Red Lion Square) Eagle Street, 35-53 (consecutive), Lambs Conduit Passage (all), Princeton Street (all including Princeton College), Red Lion Street, 20-67 (consecutive), Red Lion Square, 11-25 including Conway Hall and 33 (consecutive), Brompton Culverhouse and Tresham, Sandland Street, 22, Theobalds Road, 13-51 (odd).

Redington Froggal to include: Briardale Gardens, 1-35 (odd) and 2-14 (even), Clorane Gardens, all 1-7 and 2-18, Finchley Road 300-338 (even), Platts Lane, 2-6 and 18-34 (even), 3-67 (odd) including Westfield College Building.

Dartmouth Park to include: St. Annes Close, 1-8 (consecutive) and 9-10 Church Walk, 1-5 (consecutive).

The Conservation Area extensions and new Conservation Areas are more particularly delineated and shown edged red on plans which are available for inspection at Planning Enquiries, 5th Floor, Town Hall, Euston Road, London NW1 2RU, (Argyle Street Entrance) during normal office hours on Mondays to Fridays inclusive.

The effect of the designation is to impose important controls on development in the area. Demolition of any building or part of a building within a Conservation Area is an offence unless consent has been granted by the Local Planning Authority. Where an application for planning permission is made to the Local Planning Authority and the development would, in their opinion, affect the character or appearance of the Conservation Area, the application will be the subject of special publicity procedures under section 73 of the Planning (Listed Buildings and Conservation Areas) Act 1990. Trees in Conservation Areas are also protected and any person found executing works against trees such as felling, lopping, topping, uprooting and wilful destruction or damage without prior consent from the Local Planning Authority will be of an offence. Advertisements in Conservation Areas may also be controlled by the Local Planning Authority to avoid detracting from the appearance from the appearance of the Conservation Area.
