The Walsall Metropolitan Borough (Bridge Street, Walsall) (Disabled Persons' Parking Places) Order 1993

Notice is hereby given that the Walsall Metropolitan Borough Council propose to make the following Order under sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984.

The sides of roads specified in column 1 of Schedule 1 to this notice are authorised to be used subject to the provision of the Order, as parking places for such classes of vehicles, in such positions and on such days and during such hours as are specified in relation to those sides of roads. Vehicles shall not be permitted to wait in that parking place except upon the direction or with the permission of a traffic warden or a police constable in uniform unless it is of a specified class or in a position other than that specified.

No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.

The Order will contain exemptions for the following: vehicles to be used for the removal of any obstruction to traffic; in an emergency for police, fire brigade or ambulance purposes; in the service of any Local Authority or for the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water, electricity or of any telecommunications apparatus; to gain access to or egress from; off-street parking, loading, unloading or garaging premises adjacent to or accessible only from the parking place; or a person to board or alight from a vehicle; for purpose of delivery or collection of postal packets.

The Traffic Order specified in Schedule 2 to this Order shall be revoked to the extent indicated therein.

Full details of these proposals are contained in the draft Order which, together with a map showing the roads subject to the Order and a statement of the Council's reasons for proposing to make the Order, may be examined at the Director of Legal and Administrative Services' Office, The Civic Centre, Walsall, during normal office hours.

Objections to the Order should be sent with the grounds for making them in writing (quoting ref. PMW/HPN/2265/1002) to the undersigned not later than 3rd September 1993.
