#### *Notice of application for a licence to abstract water*

Take notice that Burmah Petroleum Fuels Limited of Burmah Castrol House, Pipers Way, Swindon, Wiltshire SN3 1RE, is applying to the National Rivers Authority for a licence to abstract water from an alluvial sand and gravel aquifer at National Grid References SK62434044, SK62394048 and SK62394050, at Burmah Petroleum Fuels Depot 2, Private Road Number 3, Colwick, Nottingham. The proposal is to abstract water at the following rates: 21 cubic metres per hour, 504 cubic metres per day, 183,960 cubic metres per year. The water will be returned to the aquifer after use.

### AVON COUNTY COUNCIL

#### *Avon County Council (Ironmould Lane, Brislington, City of Bristol) (Prohibition of Right Turn) Order 1993*

Notice is hereby given that on 12th August 1993 the County Council of Avon made an Order under sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984 as amended, the effect of which is to prohibit any vehicle proceeding in Ironmould Lane from making a right turn into the A4 Bath Road.

#### *Traffic Regulation Orders and Parking Places Orders*

#### *Pedestrianisation*

#### *"Chester—a More Friendly Place to Live"*

#### *Notice of Public Local Inquiries*

Notice is hereby given that Council of the City of Chester is holding concurrent Public Local Inquiries into the proposals to make the following Traffic Regulation Orders in accordance with the Road Traffic Regulation Act 1984:

- (1) *City of Chester (City Centre) (Prohibition and Restriction of Driving) Order 199*
- (2) *City of Chester (City Centre) (Traffic Management) Order 199*
- (3) *City of Chester (City Centre) (Prohibition and Restriction of Waiting) Order 199*
- (4) *City of Chester (Disabled Persons Parking Places) Order 199*
- (5) *City of Chester (Love Street and Brook Street) (One Way Traffic and Bus Lane) Order 199*
- (6) *City of Chester (Brook Street/Gorse Stacks) (Box Junction) Order 199*
- (7) *City of Chester (Disabled Off-street Parking Places) Order 199*

These proposals were advertised formerly in January 1993.

The Inquiries will commence at 10 a.m. on Tuesday, 14th September 1993, and last for approximately 2 weeks.

The Inspector presiding is Sir Peter Bairsto K.B.E., C.B., A.F.C., D.L., C.B.I.M.

The general nature and effect of the Orders will be to extend the current pedestrianisation scheme in the city centre, to change the traffic management arrangements to achieve this and to introduce a permit scheme to control access into St. Werburgh Street, parts of Eastgate and Foregate Streets and St. John Street.

Other streets affected are Frodsham Street, Bridge Street, Watergate Street, Northgate Street, Water Tower Street, King Street and Princess Street.

Full details of the proposals are in draft Orders and accompanying plans which together with the draft permit scheme and the statement of reasons for the proposals may be examined at the City Council Offices, The Forum, Chester, between 9 a.m. and 4.45 p.m. Mondays to Fridays.

Plans of alternative proposal put forward by objectors to the scheme will be available for public inspection from Friday, 20th August 1993.
