The Stopping-up of Highways (County of Essex) (No. 10) Order 1993

The Secretary of State for Transport hereby gives notice that, on the application of Wimpey Homes Holdings Limited, he has made an Order under section 247 of the above Act entitled "The Stopping up of Highways (County of Essex) (No. 10) Order 1993" authorising the stopping up of The Mead, connecting footpaths and a footpath loop on the north side of Pancroft, Abridge. The Order will enable residential development comprising 92 dwellings plus shops and associated works to be carried out in accordance with planning permission granted to Wimpey Homes Holdings Limited by Epping Forest District Council under Part III of the said Act.

The proposed Order will require the provision of new footpaths and a new highway maintainable at the public expense for which Essex County Council will be the local highway authority.
