- (i) *Maltings Lane*, from its junction with B1368 Green End to its junctions with The Street and Ford Street.
- (ii) *Ford Street*, from a point 50 metres south of its junction with C34, Stortford Road north-eastwards to its junction with The Street.
- (iii) *C34, Stortford Road*, from its junction with Ford Street south-eastwards for a distance of 50 metres.
- (iv) *Green Hill Close*, the whole length.
- (v) *The Street*, from its junction with Ford Street and Maltings Lane to a point 50 metres north of its junction with Pelham Road.
- (vi) *Pelham Street*, from its junction with The Street north-eastwards for a distance of 185 metres.
- (vii) *Friars Road*, from its junction with Pelham Road eastwards for a distance of 540 metres.
