ACQUISITION OF LAND ACT 1981

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by Sir Norman King, KBE (a person appointed for the purpose by the Secretary of State for Transport) beginning at 10 a.m. on 22nd September 1993 at the Reception Room B (Mandela Room) Town Hall, Sheffield S1 2HH, to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976 and the Compulsory Purchase by Non-Ministerial Acquiring Authorities (Inquiries Procedure) Rules 1990) and from any other persons having an interest in the land the subject of the Compulsory Purchase Order, and also, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Orders are Orders which have been made by Sheffield City Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:

1. *The City of Sheffield (Improvement of Penistone Road—Stage 3) (A61 Classified Road) (Side Roads) Order 1993*

This is an Order under sections 14 and 125 of the Highways Act 1980 which, if confirmed, will authorise the Sheffield City Council

- (a) to carry out the improvement of highways;
- (b) to stop up highways;
- (c) to construct new highways;
- (d) to stop up private means of access to premises; and
- (e) to provide new means of access to premises

all on or in the vicinity of the route of the Classified Road which means the Penistone Road and Hoyle Street Classified Road (A61) which the Council are proposing to improve between Barrack Lane and Meadow Street all in the City of Sheffield Metropolitan District.

2. *The City of Sheffield (A61 Penistone Road Improvement—Stage 3) Compulsory Purchase Order 1993*

This is an Order under sections 239, 240 and 250 of the Highways Act 1980 and section 2 of the Acquisition of Land Act 1981, which, if confirmed, will authorise the City of Sheffield to purchase compulsorily the land and rights described therein for the purpose of:

- (a) the improvement of Penistone Road and Hoyle Street (A61) between Barrack Lane and Meadow Street in the District of Sheffield;
- (b) the construction of other highways, the improvement of existing highways and the provision of private means of access to premises all on or in the vicinity of the route of the aforementioned highway improvement in pursuance of The City of Sheffield (Improvement of Penistone Road—Stage 3) (A61 Classified Road) (Side Roads) Order 1993; and
- (c) use by the Council in connection with the construction and improvement of highways as aforesaid

all in the City of Sheffield Metropolitan District.

Copies of the above-mentioned Side Roads Order and Compulsory Purchase Order and of the plans referred to therein have been deposited and may be seen at all reasonable hours at the Town Hall, Sheffield S1 2HH; at the Enquiry Office, Design and Building Services, 2-10 Carbrook Hall Road, Sheffield S9 2DB; at Hillsborough Branch Library, Middlewood Road, Sheffield 6 and at Upperthorpe Branch Library, Upperthorpe, Sheffield 6.

Proceedings on the above-mentioned Orders are being taken concurrently by virtue of section 257 of the Highways Act 1980.
